1. This form must be completed and submitted with supporting documentation if you wish to request your free Credit Report<sup>1</sup> including your Equifax Credit Score<sup>2</sup> from Equifax Canada. Required fields are marked with an asterisk (\*).
2. Please complete all required fields in the 'Personal Information' section. PRINT clearly using one box per character.
3. Attach clear copies of the following documentation to verify your identity:
  - **One piece of government-issued ID** showing your name, date of birth, and/or address
  - **One document** confirming the name and address on the ID (e.g., Utility, Hydro, Phone, Cable, Internet, or Financial Statements)

**Note:** We recommend that you **black out** any details that are not required to verify your identity.
